Champions for Children

A champion is someone who fights for the rights of others, and who protects and defends those who cannot speak for themselves. Richland County is filled with champions for our local youth, from individual citizens to law enforcement officers, CASA workers, mental health providers, medical professionals, school officials, and, of course, the employees of Richland County Children Services. We work together tirelessly with our community partners to ensure that the children of Richland County have everything they need to survive and thrive, whether that be a safe and loving home environment, proper access to healthcare, mental health services, or adequate food and clothing.

Since July of 2023, I have worked closely with several notable champions for children, including Director of the Ohio Network of Children's Advocacy Centers Danielle Vandegriff, Senator Mark Romanchuk, Ohio Alliance to End Sexual Violence Statewide Director of Forensic Nursing Tammy Robertson, Richland County Prosecutor Jodie Schumacher, Sheriff Steve Sheldon, Mansfield Police Chief Jason Bammann, DV Shelter Director Colleen Rice, and Director/CEO of Family Life Counseling Steve Burggraf, in order to develop a Child Advocacy Center (CAC) here in Richland County. This has been a lengthy, time-consuming process for everyone involved, but it will promote more efficient collaboration between all entities involved in child interviews. The ultimate goal of our CAC and every CAC throughout Ohio is to hopefully prevent further trauma to children since they will only need to talk about the initial allegations of their abuse/neglect one time. Without a CAC, a child may end up having to retell the details of the worst experience of their life over and over again, to doctors, police, lawyers, therapists, and others.



But I have also seen examples of forgiveness and redemption, with families healing themselves and learning how to be champions for each other. 

Richland County Multi-Disciplinary Team (MDT)



The Ohio Network of Children's Advocacy Centers conducted a training (entitled **Crime Scene to Trial**) at Tiffin University from 7/16/24-7/18/24 that was focused on providing hands-on training to MDT entities (multidisciplinary teams) in responding to child abuse/neglect cases. Eleven individuals from Richland County (representing RCCS, the Richland County Prosecutor's Office, Mansfield Police Department, the Richland County Sheriff's Office, and the Domestic Violence Shelter) worked together on two teams in order to learn methodology pertaining to processing child maltreatment crime scenes, interviewing witnesses, interrogating suspects, conducting forensic interviews, applying for search warrants, and making decisions regarding legal charges.



Legal Advocacy

RCCS attorneys Jeff Kiggans and Sarah Exten worked tirelessly throughout 2024 to ensure that Agency-involved youth had excellent legal advocacy in the court system.

Throughout 2024, the RCCS legal team filed 241 new complaints in court, filed for ex parte (emergency custody) 35 times, assisted in obtaining court approval for the residential treatment of 11 children, conducted 161 meetings with RCCS casework staff to review case information prior to filing, and averaged 8 court appearances per work day.



Medical Advocacy

Every child who comes into Agency care is assessed for issues related to medical neglect. Many of these children have never been to a dentist and have severe dental issues. Others have chronic health problems that have never been addressed by their parent(s). Our nurse (Renee Blankenship) ensures that all Agency-involved youth are connected with the medications and services necessary to treat their pre-existing conditions, whether those are physical, mental or emotional.







Our Impact

Richland County Children Services facilitated the disbursement of over \$1.8 million in 2024 for various programs to help support our clients, foster parents, adoptive parents, and kinship families in caring for the children in their homes. The PRC (Prevention, Retention & Contingency) program was funded through a contract with the local Job & Family Services agency for a total amount of \$79,320. An outline of our local community support programs and their associated expenditures is below:

- **KPI (Kinship Permanency Incentive) \$205,800 -** Paid directly from the State to kin families to help with the costs associated with the child (ren) living with them
- **PRC (Prevention, Retention & Contingency) \$79,320 -** Paid to kin families to help with the costs associated with the child(ren) living with them
- ESAA (Emergency Services Assistance Allocation) \$150,239 Paid to families for things such as rent, utilities and furniture in an effort to keep children in their own homes or return them to their homes
- **Kinship Care \$67,681 -** Paid to kin families for things such as rent, utilities and furniture in an effort to help them care for the child(ren) in their home
- Foster Parent Training \$16,546 Stipends paid to foster/adoptive parents and prospective foster/ adoptive parents for attending training
- Adoption Subsidies \$1,151,245.50 Paid to parents who adopted children in Agency custody
- In addition, the Agency paid \$144,766 in childcare payments for children placed with foster parents who work outside the home.
